 - Participating tenderers must deposit Earnest Money Deposit (EMD) of (i) Rs.5,00,000/-(Rupees Five lacs only) in the form of Demand Draft in favour of "HINDUSTAN ZINC LIMITED", payable at Udaipur, Rajasthan.
 - (ii) Cheque, Bank Guarantee (B.G.) or any outstanding payment with Hindustan Zinc Limited (HZL) shall not be accepted / considered as EMD.
 - The amount of EMD deposited is liable to be forfeited if successful tenderer(s) (iii) do not accept the work awarded.
 - The EMD amount will not attract any interest and the EMD amount will be (iv) returned to unsuccessful tenderers after finalization of Work Order.

MAIN TERMS & CONDITIONS

1. SCOPE OF WORK ---

Transportation of the Finished Goods (FG) from different smelters of Hindustan Zinc Limited (HZL), to various destinations in India by road/MMT as indicated in the Annexure(s) attached. Please quote the rates in Annexure(s) itself. Also maintain the rates in excel sheet format with you which we may need subsequently (do not add or delete any row even if you are not quoting for any particular destination)

- i. Transporters have to lift daily indented quantity per destination within 48 hours (next two working day) from HZL Smelters as mentioned in Annexure(s) as per program given in writing by mail or on ITMS Portal from the Officer Incharge Sales / Dispatch Department of Smelter. The quantity mentioned in Annexure "D" is only indicative and can vary substantially specially during last week of the month depending upon the customer's requirement. However, 48 hrs clauses will not be applicable after 25th of the month and vehicle placement is to be ensured within 24 hrs on receipt of indent from S&D.
- ii. In case any 3PL logistics service provider wish to transport FG to various destinations through Multi Modal Transport (MMT) system, then they may also quote their rates specifically mentioning that the mode of movement is through MMT with proper break up of rail and road cost.
- iii. In case of primary logistics (From Plant), if any new destination required to be serviced after finalization of transportation contract then freight applicable within 50 KM distance w.r.t. existing destination shall be proportionately arrived for new destination based on per ton per kilometer basis and accordingly freight shall be increased or decreased based on existing nearest destination available in contract.
- iv. In case of secondary logistics (From Depot), if any new destination required to be serviced after finalization of transportation contract then freight applicable within 20 KM distance w.r.t. existing destination shall be proportionately arrived for new destination based on per ton per kilometer basis and accordingly freight shall be increased or decreased based on existing nearest destination available in contract.
- v. In case of dispatches from Depot (secondary movement) Service provider will have to place lorries by 16:00 hours for loading against the plan received one day in advance (before 18:00 hours) in writing by mail only from Regional Manager office. If required Lorries not placed than Regional Manager will be authorized to apply Risk and Cost over the left out quantity on next day.
- vi. Program from Smelters will be given one day in advance and vehicles for 70% (+/-5%) of indented quantity (to the maximum limit as specified in annexure) must be placed without fail on next day otherwise flat penalty of Rs.2000/- will be imposed for failure in placement for a destination. However, this is applicable only when program given for a destination is for more than one vehicle. In case the indent quantity is for one vehicle, then the same should be placed within 24 hrs failing which risk and cost shall be applicable, but no penalty will be imposed. Vehicles for Indent quantity (5% tolerance) must be completed within 48/24 hours (as applicable) to avoid risk purchase. Risk Purchase shall be done under written





intimation and proof of failure against indent as per contract to service provider by Sales and Dispatch Department of dispatching unit.

In case of default in placing the vehicles as per the indent, HZL will arrange placement of vehicles from the open market at whatever rates received against the enquiry.

In case the transporter back out from the contract, then HZL will have the right to recover all the losses incurred during the balance period of the contract from the defaulting transporter.

- vii. The Service provider shall ensure that at the time of taking delivery at the dispatching unit, the exact weight as per the weigh bridge at dispatching unit and the number of ingots / pieces / bundles are properly and correctly recorded in the relevant Lorry Receipt (LR) which would be the basis for verification and proper complete delivery at destinations. However, the consignments will be weighed both at dispatching unit and destinations on respective weigh bridges to record the weights at both ends.
- viii. In transit if the duplicate copy of excise invoice if lost by lorry driver than Service Provider will be penalized Rs.1000/- per invoice and also any loss due to non-delivery of excise document will be recovered from the Service Provider. To take in-put credit benefit on loss of GST Invoice enroute service provider will be responsible to file and submit the original FIR to the destination Receipt incharge, to process the in-put credit benefit. Till in-put credit benefit is granted to the customer / depot, the amount equal to the GST value will be kept on hold in account of service provider with intimation.
- ix. Vehicle deployed for loading must have even surface good quality tarpaulin and loaded cargo must be covered by tarpaulin, tying it securely and sealed. Sales & Dispatch department of Smelter / Regional Manager at Depots would ensure loading in dry condition & service provider would ensure delivery of consignment in same state at destination. Failure of this may lead to return of consignment back to Smelter / Depot free of cost if rejected or will be subjected to recovery to the nature of loss to consignment shall be binding on Service Provider.
- x. HZL reserve the right to award the contract to any party as parallel as partly or fully or contract / tender can be terminated without assigning any reason to it.
- xi. Service Providers quoting freight for Secondary Movement i.e. dispatches from Depot(s) onward must have their Branch office nearby Depot location.
- xii. Only Indian Bank Association (IBA) Approved / Certified Transporters with minimum annual turnover of Rs. 5 Cr. are eligible to apply under this tender.
- 2. Service Providers have to submit the Bank Guarantee (BG) for Rs.25 Lacs as Security Deposit within 15 days on award of contract valid for a period of six months in excess of validity period of the contract.
- 3. Contract period will be effective from 1st April, 2019 to 31st March, 2020.
- 4. Service Provider should quote the Freight rate for transportation inclusive of all expenses such as road tax, toll tax, insurance, permit expenses, statutory levies,





demurrage, mathadi union / varai charge (if any) etc. as and where applicable. GST extra as applicable.

5. For all destination rates to be quoted for full trucks load of 35 to 41 MT only which will be considered as base freight rate.

Indent received from HZL is less than 35 MT then following matrix of freight will be applicable:

- For Primary Logistics:
 - 1. Truck Load >= 35 MT up to 41 MT Base Freight Rate applicable
 - 2. Truck Load >=24 MT up to 34.999 MT Base Freight Rate + 5% Extra Freight
 - 3. Truck Load >=18 MT up to 23.999 MT Base Freight Rate + 8% Extra Freight
- For Secondary Logistics:
 - 1. Truck Load >= 21MT up to 41 MT Base Freight Rate applicable
 - 2. Truck Load >=16 MT up to 20.999 MT- Base Freight Rate + 10% Extra Freight
 - 3. Truck Load >=9 MT up to 15.999 MT Base Freight Rate + 20% Extra Freight

According to above matrix freight to be quoted for Base rate only.

- 6. Loading & unloading shall be in HZL account.
- 7. Transit insurance of material shall be in HZL account. HZL shall take appropriate marine insurance policy to cover the risk for transportation of the goods involved. The service provider shall produce requisite documents and evidences as may be desired for lodging of claims by HZL against partial or total loss. HZL however reserves its right to take or recover such losses from the service provider in the event of loss of goods, loss of value of goods due to negligence of the service provider and the decision of HZL on such recovery shall be final and binding on the service provider. However, under Insurance the Excess clause shall be applicable.
- 8. Detention at loading point will be not payable.
- 9. Detention per lorry per day at unloading point is however payable @ Rs.2000/- per day. For calculating detention example: If lorry reports at destination on 10th March and gets unloaded on 11th than there will be no detention payable. If the same lorry gets unloaded on 12th or 13th than detention shall be payable. Here, if 11th is planned holiday (Sunday/ National holidays / State or local festival) at destination in such case detention applicable will be from 13th.
- Freight Rate will be firm & fixed till the period of contract. However, HZL will make changes in its Basic Freight Rate against escalation in Diesel price as per formula given below.
 - Formula: HZL shall increase/ decrease its Basic Freight Rate by 0.30% proportionately for every 1% change in diesel price. Base diesel price shall be declared price of IOCL at respective state capital.
- 11. Service provider is required to submit Freight Bills on TMS Portal once in a fortnight (15 days) for dispatches from Smelters and to Regional Manager Offices for dispatches





made from Depots, for which payment will be released within 15 days after submission of bills. However, delay in payment of bill due to any reason will not vitiate other terms of the contract nor will it give any right to the service provider to suspend the work. The submission of bills should not be delayed beyond two billing cycles otherwise HZL will not be responsible for any delay in release of payments.

- 12. Dead Freight is not applicable in case transporter place the vehicle with higher loading capacity vehicle than the indent provided by HZL. However, payment of dead freight is applicable i.e. when loading up to vehicle registered capacity is not done by HZL (even after giving requisition for the same) due to shortage of sale order/material etc. can be authorized either by Marketing or Central Logistics.
- 13. Transit time is allowed at the average 350 km per day excluding the day of dispatch and reporting at destination. Transit time is the actual running time of vehicle from origin to destination.

In case if vehicle is reporting next working day of Sunday or any national / state holiday at destination than the holiday days would be not considered under transit period for vehicles supposed to report on holiday days (but if the depot is kept opened for expected delivery in special case, these norms would not be accepted). But in case if the vehicle instead of reporting before holiday (actual / theoretically reporting day) reports after holiday in such case for calculating Delay penalty holiday days will be counted. For example:

Assumption: Date - 1st Oct. is Sunday and 2nd Oct. is Gandhi Jayanti (national holiday). Case 1: Suppose – Calculated reporting date is 01st Oct., but destination office endorses reporting date as 03rd Oct. In such case 01st & 02nd Oct. will be not considered under transit period and will not attract delay penalty.

Case 2 : Suppose – Calculated reporting date is 30th Sept. and destination office endorses reporting date as 03rd Oct. In such case 01st & 02nd Oct. will be considered under transit period and will attract delay penalty.

Case 3: Suppose – Calculated reporting date is 30th Sept. and destination office endorses reporting date as 01st Oct. and unloads on 03rd Oct. in such case one day delay will be considered and will attract delay penalty. But service provider will not be liable for any detention as 01st & 02nd is holiday.

Penalty of Rs.2000/- per day will be imposed for delayed delivery in reporting of vehicle w.r.t. transit period prescribed in enclosed Annexure(s).

However, delay in delivery can be condoned on valid ground such as vehicle breakdown or vehicle detained by some agency or natural calamity or force majeure situations for which information should be furnished within transit time provided under annexure(s) attached of the happening and bill / document to be submitted as proof of occurrence with the freight bill for the approval of the delay occurred. Service provider has to provide information to Sales and Dispatch Department / Regional Manager Office as the case may be.

Transshipment of goods is strictly not allowed in route unless warranted due to failure of vehicle to move further or accident incurred or vehicle detained by agency for some reason or lorry for a particular destination is not available. In case of vehicle accident /





break down / detained service provider has to inform to Sales and Dispatch / Marketing Department through email or fax and get approval prior to transshipment. While submitting freight bill for such vehicles service provider is required to attach the approval provided with proof of documents showing condition of vehicle under accident / break down / detained.

Transshipment without valid approval shall attract penalty of 1/3 of the freight payable for the transshipped lorry.

While carrying out any such transshipment service provider has to take all care so that no damage occurs to the product and its packing. Further, cost of repacking of broken bundles have to be borne by service provider.

Transshipment done with approval of Sales / Dispatch Department of Smelter or Marketing Department to accommodate emergency requirement or last day of the month to accommodate heavy dispatch due to month end will not attract any penalty.

Clubbing of material of two vehicles into one vehicle is not permitted. In case clubbing is done then it will attract penalty of Rs.5000/- per vehicle.

14. Service Provider's to ensure:

- Service provider shall provide all necessary safety gadgets like safety shoes, helmets, reflective jackets etc to their employees when they enter in the HZL premises.
- The service provider's employees have to ensure strict compliance of safety measures adopted by HZL.
- The service providers shall be responsible and liable for payment of salary, wages and other legal dues of the employees employed by him for the purpose of rendering service required by company under this agreement.
- The service providers shall maintain books, account, records and documents comply with all statutory rules and regulations which are applicable to the service providers for the fulfillment of the terms of this agreement.
- The service provider shall comply in all respect with the provisions of all statutes, rules and regulations applicable to the service provider and/or to the service provider's employees including but not limited to PF act, minimum wages act, ESI Act & Bonus Act & particular the Contract labour (Regulations & Abolition Act, 1970) & the rules made there under.
- Service Provider has to ensure that the wages to their employees is distributed by 7th of every month as per the rates decided by HZL from time to time and the PF and ESI are deposited by 20th of every month. In case of deviation, HZL shall impose suitable penalty on the Service Provider.
- The Service provider is required to furnish that there is no enquiry /investigation pending by the police against their employees deputed to carry out this job.
- Service provider shall ensure total compliance of Indian Motor Vehicle Act and amendments thereof as made from time to time. The service provider shall be responsible for any breach/es and damages resulting from such breach/es shall be to service provider's account.
- The service provider shall be responsible to secure compliance with all central and state laws as well as the rules, regulations, bye-laws / notifications and orders of the local authorities and statutory bodies as may be in force from time to time.





- The service provider shall make good at his own cost, any damages to the property of anybody, persons, local authorities etc. due to or arising from his operations covered by under this contract.
- Service provider has to follow all applicable EHS Regulations.
- 15. Loading of FG will be done as per the loading capacity of vehicle mentioned in the RC. No overload will be allowed.
- 16. Service Provider has to ensure that all their vehicles are fitted with GPS devices and regular tracking of vehicles is done and SIT report is mailed on daily basis to respective S&D units and central logistics. HZL will suggest a common GPS Service Provider and the decision of HZL will be binding on all the Transporters to use the services of the common service provider so as to ensure that tracking of all the vehicles is done on a common single platform. Penalty of Rs.2000/- per vehicle will be imposed if the vehicle is dispatched without GPS device.
- 17. Service Provider has to ensure road worthiness of the vehicles deployed for FG loading and should ensure strict compliance of our check list which is attached as Annexure "C" with the tender document. In case any vehicle does not comply with our check list then we will have all rights to reject the vehicle and disallow the same.
- 18. Service Provider will take necessary steps to protect the material from loss, damage or deterioration till it gets delivered to destination. Transporter shall be responsible for all loss, destruction, damage and or deterioration of the material from any cause, whatsoever, while in transit or during handling.
- 19. Decision for awarding Contract / Work Order shall be at sole discretion of HZL applying reverse auction / negotiation or both & final fitness of the tenderer.

VEHICLE & DRIVING STANDARD

VEHICLES AND DRIVING

All vehicles coming to HZL plant premises should follow below mentioned criteria for Vehicles as well as Drivers. If any vehicle is not fulfilling any of the criteria then it will not be allowed to plant premises.

NO-GO Criteria For Vehicles -

- 1. **Seat Belt -** Vehicle must have functional seat belts for all Seats & 3 Point Contact type seat belts for driver & helper.
- 2. **Vehicle Fitness** Any vehicle contracted to HZL should be certified for fitness on Roadworthiness by RTO (in form 38). New vehicle having RC of less than 2 Year old not to produce any fitness certificate separately.
- 3. **Tyre -** All Vehicle must comply with HZL guidance on Tyre(should have depth of 1.6mm in the centre of the tyre)
- 4. **Tractor Trolley** Tractor with trolley has been banned in HZL .Only Auger with Tractor will be allowed for plantation.
- 5. **Retro-Reflective Tape** Retro- Reflective tape required in the vehicle (side/front & back) for easy identification of the vehicle.
- 6. **Spark Arrestor** Any vehicles carrying flammable & explosive materials such petroleum products i.e. HSD, FO, tyre oil, propane gas etc.
- 7. **Run Protection** Side Run (SUDP) & Rear Run(RUDP) Protection should be available in all HMV.
- 8. **Third Axial Provision** Empty truck can have lifted third axial but loaded truck should have third axial on ground with running condition.
- 9. RC & Insurance Paper Vehicle should have a valid RC copy along with Insurance Paper.
- 10. **Reverse Horn** Vehicle must have working & audio-able reverse horn.
- **11. Indicators/ blinker & Head lights -** Vehicles must have working indicators/ blinkers and Head lights.
- **12.** Wiper at driver side Vehicles must have working wiper on wind screen at Driver side.
- 13. **Side Mirrors** Vehicles must have side mirror at driver & helper sides
- 14. **Fire Extinguisher** LMV should have 1KG metal body and HMV should have 4KG metal body type Fire Extinguisher (IS 15683).
- 15. **Disabled Triangle** All vehicles (LMV & HMV) should have disabled Triangle which has to be used during vehicle breakdown condition.
- 16. First Aid Kit All vehicles (LMV & HMV) should have one First Aid Kit for emergency Usage.

NO-GO Criteria For Drivers -

- 1. Seat Belt Driver has to use Seat belt all the time whenever will be inside the vehicle.
- 2. **PPE** Safety helmet, safety shoes, Goggle & reflective jackets (except hazardous goods carrying vehicles)





- 3. **Medical Fitness** All Vehicle drivers must have a medical fitness certificate confirming the parameters stipulated by HZL. Please refer to the Annexure-1.
- 4. **Intake of Alcohol & Drugs -** Drivers will not be allowed to drive vehicle found taking drugs/Alcohol.
- Haz-Chem Training All Drivers carrying Hazardous chemicals and/or material possess a valid training certificate on Haz-Chem from state Government approved institute or agency(after completion of CMVR training driving licences will be issued by RTO). Driver should have TREM Card with them.
