

Budget earmarked for plantation/green belt development with drip irrigation system after expansion is Rs. 1200 Lakh (Capital) and Rs. 20.0 lakh(recurring). Plantation proposed within and outside the mine lease area lease during 2018-19 to 2022-23 total 56030 saplings will be planted on 43.1 Ha area (cumulative plantation 246030 on 2331. Ha), during 2023-24 to 2027-2028 total 10660 saplings will be planted on 8.2 Ha area (cumulative plantation 256690 on 241.3 Ha). PP shall implement the protection proposed for the survival of the plantation. PP shall engage the expert agency to increase the plantation density to at least 2500 saplings/ha. PP shall develop an alternative grazing in lieu of grazing land if already used by the PP for mining activity and take NOC from the concerned authorities for use of grazing for mining purpose. Growth of each plant needs to be monitored and record should be maintained, the record should also be maintained for no of species planted, type of species planted, survival rate etc. The budget earmarked for plantation shall be kept in separate bank account and should be audited annually. 
