The Govt. of India through its *Swachh Bharat* Mission has proposed a multi-stakeholder initiative to clean up Moinuddin Chishti Dargah Complex, Ajmer. The initiative is being coordinated by the Ministry of Drinking Water & Sanitation with other key Ministries as well as State, City and Site Managers and Hindustan Zinc India Ltd.

The Dargah complex is one of the holiest Islamic sites in India located within the walled city of Ajmer and is visited by 38 Lac pilgrims annually. Expanding organically over the last 700 years, the complex is facing issues related to degrading heritage, visual clutter, poor public amenities and services, overcrowding and poor safety etc.

The Swachhta Abhiyaan for the Dargah Complex thus envisioned is structured as follows:

1. Augmentation/Upgradation of Engineering Services
  - a. Electric system
  - b. Water supply & Drainage
  - c. Sewerage
  - d. Rain water
  - e. Solid Waste Management
  - f. Drinking water
2. Construction and renovation of Toilets
3. Placement of Mechanized cleaning systems, waste recycle machinery etc.

(Note: All upgradations to be aligned with a long-term vision for the Complex and its vicinity, which is to be prepared simultaneously)

#### **Eligibility Criteria**
