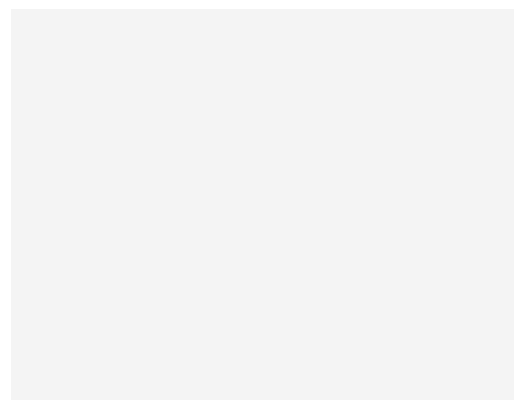

With this, HZL's cumulative contribution to the exchequer over the past five years stood at Rs 77,803 crore.

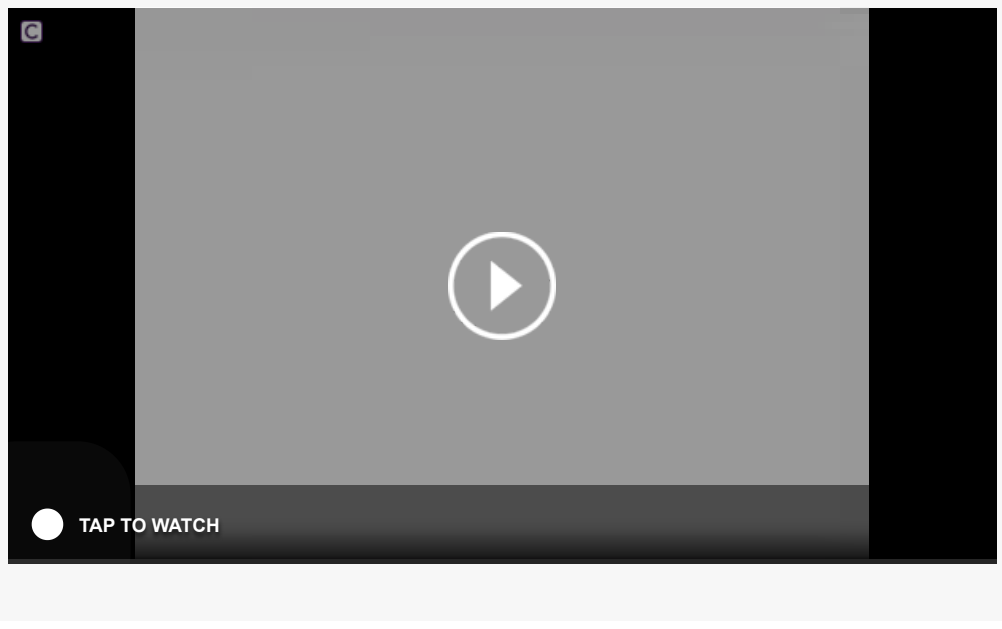

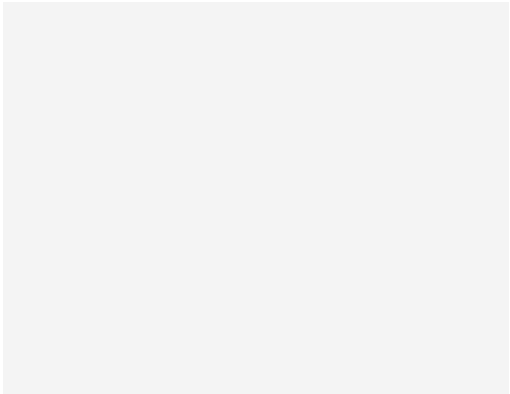
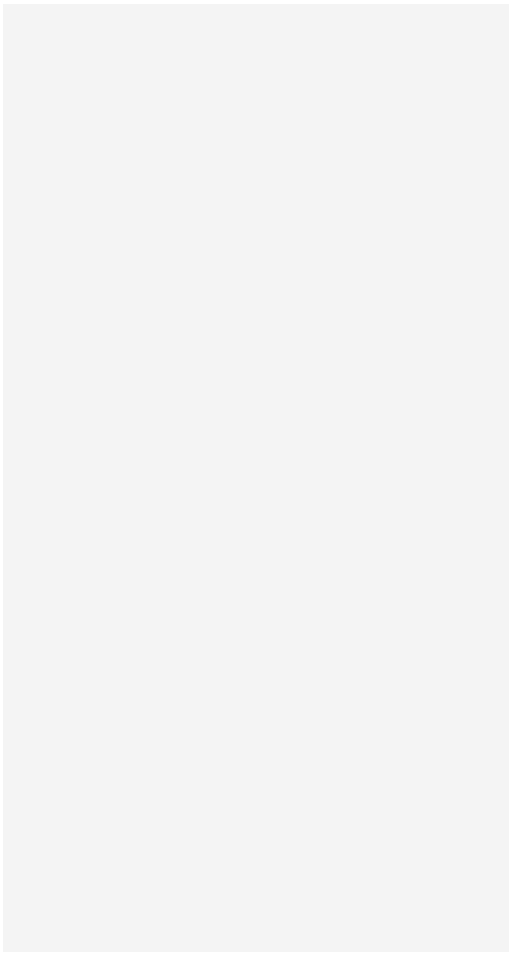
